Background

The 2022 Hillsborough County Medical Association/Rivero, Gordimer & Company, PA Scholarship is targeted to medical students who demonstrate a commitment to organized medicine and public health initiatives, and is based on financial need and academic achievement. One \$1,500 scholarship will be awarded to a successful candidate from the University of South Florida (USF) Morsani College of Medicine.

This scholarship, originally established in the memory of Rex Meighen of Rex Meighen & Company, has been presented annually to a deserving USF medical student for over 40 years.

In addition, the HCMA Foundation Board has agreed to match the 2022 scholarship. Two checks, totaling \$3,000, will be presented to either one or two scholarship recipient/s at the February 8, 2022 Membership Event.

Eligibility

- Applicant must be a second, third, or fourth year medical student.
- Applicant must be a United States Citizen.
- Applicant must have been a member of the Florida Medical Association and the Hillsborough County Medical Association for a minimum of one year and agree to maintain those memberships through the duration of enrollment in the USF Morsani College of Medicine.
- Applicant must be currently enrolled full time at the USF Morsani College of Medicine.
- Applicant must submit a recommendation from the Dean (or Dean's representative) of the USF Morsani College of Medicine.
- Applicant must submit an official copy of his/her most current transcript.
- Applicant must demonstrate personal motivation for excellence in academic achievement, and personal integrity and character, as exemplified by leadership, community involvement, public health initiatives and concern for others.

- Attendance at the Annual or Interim Meeting(s) of the American Medical Association or Annual Meeting of the Florida Medical Association will be a strong consideration.

Recipient/s must attend the February 8, 2022, Hillsborough County Medical Association Membership Event, to accept the scholarship.
